

[ATIDAN EXPLORER] FOR MICROSOFT® SHAREPOINT

End-User License Agreement

Please read this End User License Agreement (“**Agreement**”) carefully before proceeding. This Agreement licenses software to you, either an individual or single entity, (the “**you**”, “**your**” or “**End User**”) from **ATIDAN IP HOLDINGS, INC.** (“**Atidan**”) and contains warranty and liability disclaimers. By downloading, installing, copying or otherwise using [Atidan Explorer] for Microsoft® SharePoint (“**Atidan Explorer**”), you are confirming that you have read and understand this Agreement and agree to be bound by the terms of this Agreement. If you do not agree with the terms of this Agreement, you should not download or install or use Atidan Explorer.

1. Overview.

Atidan Explorer is a “web part add-on” software program providing a tree-view control, to interface with Microsoft® SharePoint Server 2007 (“**Sharepoint**”). Atidan, in its sole discretion, may, but shall not be obligated to, update Atidan Explorer to work with future version of Sharepoint.

2. License.

Subject to all of the terms of this Agreement, Atidan grants to you a non-exclusive, non-transferable, royalty-free, limited license, without the right to sublicense, to: (i) install and use the Atidan Explorer on a single computer solely for your internal purposes; and (ii) make copies of Atidan Explorer in machine-readable form solely for backup and archival purposes; provided you reproduce on any such copy all copyright notices and any other proprietary legends found on the original. Atidan expressly reserves any and all rights in and to Atidan Explorer not specifically granted to you herein. The license in this Agreement is effective until terminated under the terms of this Agreement.

3. Restrictions.

You may not make or distribute copies of Atidan Explorer, or electronically transfer Atidan Explorer from one computer to another or over a network, other than as permitted under Section 2, above. You may not decompile, reverse engineer, disassemble, create software substantially similar to Atidan Explorer or otherwise reduce Atidan Explorer to a human-perceivable form, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation. You may not modify, sell, rent, loan, lease, transfer, sublicense, resell, network, reproduce, display, distribute or create derivative works based upon the Atidan Explorer, any part thereof. Furthermore, you are not allowed to post or otherwise make Atidan Explorer available on the Internet other than as expressly stated herein. You must not remove or alter any copyright, trademark or patent notices embedded in or affixed to Atidan Explorer.

4. Ownership and Copyright.

Atidan Explorer and any improvements, modifications, enhancements, customizations, changes, updates and upgrades to and compilations and derivatives of Atidan Explorer, whether made by Atidan, you or any other party, and all copies thereof, whether created or developed prior to, during or after the Term, and all copyrights, patents, trade secrets, trademarks, and all other proprietary rights related to or embodied in any of the foregoing are proprietary to and belong exclusively to Atidan and title to them shall remain at all times with Atidan. You acknowledge and agree that this Agreement contains no right in or license grant to any source code embodied in or related to Atidan Explorer. Furthermore, Atidan Explorer is protected by all applicable copyright or other intellectual property laws and treaties throughout the world. This Agreement is not a sale of Atidan Explorer. All rights in Atidan Explorer and in all related intellectual property not expressly to you under this Agreement are reserved by Atidan and its suppliers.

5. Publicity and Marketing.

Notwithstanding anything to the contrary in this Agreement, either you or Atidan may publicize the existence of the licensing relationship and the identity of the product(s) licensed hereunder, provided that neither you nor Atidan shall disclose any of the other terms of this Agreement to any third party without first obtaining the written consent of the other party. You agree to allow Atidan to issue a “win” press release announcing you as a customer and grant Atidan a license to use and publish your name and/or trademark as part of Atidan’s customer lists, in the form provided by you, and in compliance with your applicable trademark usage policies. You consent to Atidan’s use of a “customer success story,” “case study” or the like depicting your use of Atidan Explorer. You agree to provide quotations for use by Atidan in creating such depictions. You agree to serve as a reference account for Atidan. As such, Atidan may provide

your name and contact information to, and you may be contacted by, members of the media, market analysts, potential customers or other parties interested in your opinion of Atidan and its products or services, including but not limited to, Atidan Explorer. You and Atidan agree, at the request of the other party, to place the other party's logo and a link to the other party's web site on its own web site.

6. Disclaimer of Warranties and of Technical Support.

NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS AGREEMENT, ATIDAN EXPLORER IS PROVIDED TO YOU "AS IS" AND WITHOUT ANY TECHNICAL SUPPORT. YOU ACCEPT ALL RISKS THAT MAY ARISE FROM THE DOWNLOADING, INSTALLATION AND/OR USE OF ATIDAN EXPLORER, INCLUDING BUT NOT LIMITED TO ERRORS IN TRANSMISSION OR CORRUPTION OR LOSS OF DATA, SOFTWARE OR THIRD PARTY PRODUCTS. ATIDAN MAKES NO WARRANTY, AND EXPRESSLY DISCLAIMS ANY WARRANTY, FOR ATIDAN EXPLORER, WHETHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, A WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. THE ENTIRE RISK ARISING OUT OF USE OR PERFORMANCE OF ATIDAN EXPLORER REMAINS WITH YOU. ATIDAN MAKES NO WARRANTY THAT USE OF ATIDAN EXPLORER WILL BE UNINTERRUPTED OR ERROR-FREE. ATIDAN MAKES NO WARRANTY AND DISCLAIMS ANY LIABILITY REGARDING THE ACCURACY OR VALIDITY OF ANY DATA AND/OR INFORMATION AVAILABLE THROUGH USE OF ATIDAN EXPLORER OR RESIDING ON OR PASSING THROUGH ANY INTERCONNECTING NETWORKS USED IN CONNECTION WITH ATIDAN EXPLORER. IN NO EVENT SHALL ATIDAN BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY CLAIMS, LOSSES OR DAMAGES ARISING FROM RELIANCE ON ANY DATA OR INFORMATION AVAILABLE ON OR OBTAINED THROUGH USE OF ATIDAN EXPLORER. *Your sole and exclusive remedy in the event Atidan Explorer fails to function, or in the event of any other breach of this agreement by Atidan, is to terminate this Agreement and cease all use of Atidan Explorer. Some states do not allow the exclusion of implied warranties or limitations on how long an implied warranty may last, so portions of the above exclusion may not apply to you. You may also have other rights that vary from state to state.*

7. Limitation of Damages.

ATIDAN SHALL NOT BE LIABLE FOR, AND YOU SHALL BE SOLELY RESPONSIBLE FOR YOUR HARDWARE, NETWORK CONNECTIVITY, HOSTING SERVICES, OPERATIONAL SOFTWARE, THIRD PARTY PRODUCTS, SECURITY, THE BACKUP AND STORAGE OF ANY DATA AND THE ACTS AND OMISSIONS OF YOUR CONTRACTORS. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL ATIDAN OR ITS AFFILIATES, OR THEIR RESPECTIVE OFFICERS, DIRECTORS, PRINCIPALS, OR EMPLOYEES BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, EXEMPLARY, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES OR LOSS (INCLUDING DAMAGES FOR LOSS OF BUSINESS, LOSS OF PROFITS, LOST DATA, OR THE LIKE), WHETHER BASED ON BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE, EVEN IF ATIDAN OR ITS AFFILIATES, OR THEIR RESPECTIVE OFFICERS, DIRECTORS, PRINCIPALS, OR EMPLOYEES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. 8. Export.

By downloading, you acknowledge that the transfer of technology across national boundaries is regulated by the United States Government. You shall not acquire, ship, transport, export or re-export Atidan Explorer, directly or indirectly, into any country in violation of any applicable law (including, but not limited to, the United States Export Administration Act and the regulations promulgated thereunder) nor will you use Atidan Explorer for any purpose prohibited by such laws. You warrant and represent that neither the U.S. Bureau of Export Administration nor any other federal agency has suspended, revoked or denied your export privileges.

9. Third Party Products.

(a) You acknowledge that in order to enjoy the full benefit of the license to Atidan Explorer, you must procure certain third party software, including Microsoft® SharePoint Explorer, and maintain the minimum hardware, software and Internet connectivity recommended for the optimal use of such third party products (collectively, “Third Party Products”). You represent and warrant that you own or have the right to use the Third Party Products and you understand and acknowledge that your use of any of the Third Party Products shall be subject exclusively to the terms of the license or other agreement with the owner or provider of the Third Party Products to which Atidan shall not be a party and for which Atidan disclaims all liability.

(b) Parties other than Atidan provide may provide services or distribute and sell products designed to interface with or work in conjunction with Atidan Explorer. In addition, Atidan may provide links to the Internet websites of its affiliated companies and other businesses. You understand and agree that Atidan is not responsible for examining or evaluating, and Atidan does not warrant the products or services of, any of these businesses or individuals or the content of their Internet websites. You acknowledge and agree that Atidan does not warrant that any Third Party Products will work properly with, and will not interrupt or disrupt the use of, Atidan Explorer, or that Third Party Products will be free of viruses, worms, or Trojan horses, trap doors, or other forms of corruptive code. Atidan makes no representations or warranties concerning the performance, effectiveness or any other aspect of any Third Party Products.

10. Termination. Atidan may terminate this Agreement, including the license granted hereunder, at any time by sending you written notice, which notice may be sent via email. Without prejudice to any other rights that Atidan may have, this Agreement, including the license granted hereunder, will terminate automatically without further notice if you fail to comply with any of the provisions of this Agreement. Upon any termination, you shall immediately cease all use of Atidan Explorer and all related materials, in whatever form, and you shall destroy all copies of Atidan Explorer, including any partial copies thereof, from your computer. All provisions of this Agreement which by their nature should survive or which relate to ownership, warranty and limitations on liability shall survive termination of this Agreement and remain in full force and effect.

11. General.

This Agreement shall be governed by the substantive and procedural laws of the Commonwealth of Pennsylvania without regard to its conflict of law provisions. You and Atidan agree to submit to jurisdiction and venue in the state courts located in Bucks County, Pennsylvania and in the U.S. District Court in the Eastern District of Pennsylvania and waive any claim or defense that such forum is not convenient or proper. This Agreement contains the entire agreement between the parties with respect to the subject matter hereof, and supersedes all prior or contemporaneous agreements or understandings, whether oral or written. If a court of competent jurisdiction holds any part of this Agreement invalid or unenforceable, the remainder of the Agreement shall be interpreted so as to reasonably affect the intention of the parties. This Agreement and the rights and obligations of the parties under this Agreement shall not be governed by the provisions of the United Nations Convention on Contracts for the International Sales of Goods or the United Nations Convention on the Limitation Period in the International Sales of Goods as amended.
